IF THERE IS ANY DAMAGE WHILE THE DAM IS BEING TAKEN OUT IT WILL BE REPAIRED AT NO COST TO THE VILLAGE. COUNCILMAN DILULLO SUGGESTED THE VILLAGE TAKE PICTURES OF THE AREA BEFORE ANY WORK IS STARTED. THERE WAS MUCH DICUSSION ON THE MIREX THAT YEARS AGO WAS FOUND IN THE CREEK. SHIELA ABRAHAM OHIO EPA STATED THAT THE AREA HAS BEEN TESTED OVER THE YEARS AND THE LEVELS ARE FOUND TO BE NORMAL FOR THE CREEK.
